9/26/2009	47	Breaks into Massicotti's home again and steals more clothing 1		
9/30/2009	47	Attacks Laurie Massicotti on Cosy Cove Lane in Tweed, near his home. He blindfolds		
2/30/2002	.,	and sexually assaults her. She cannot identify Williams. 1		
10/24/2009	47	Breaks into a home that contained only males. Takes four photos and leaves because		
		no women live there 1		
11/16/2009	47	Breaks into Marie-France Comeau's house, and steals some undergarments and takes		
		photos. She isn't home. 1		
11/17/2009	47	Breaks into Marson-Cook's home and steals sex toys and lingerie. He leaves a		
		derogatory message on her computer. She contacted the police. 1		
		Hides behind Comeau's furnace. When she comes to look for her cats in the		
		baasement, he attacks her. and binds her to a steal post. He wraps duct tape around her

		before he records a two-hour long video which includes the rape and torture of Comeau. He murders her by asphyxiation. Duct tape is used to cut off her air supply.
